VENDOR INFORMATION

Festival dates – July 10 (10-5) &

11 (10-4), 2010

Street dance – July 9

Location: All booths are located on the town square in Hayesville, NC and are approximately 10' X 10'.

FEES: \$75 per booth. The deadline for applications is May 15, 2010. For all applications postmarked after the May 15 deadline, the fee will increase to \$100. *Since space is limited, registrations after May 15 will be accepted on a first-come, first-served basis.*

GUIDELINES:

*Objects must be handmade, and any mass-produced components within the object must be clearly of secondary importance to the handmade aspects of the object.

*All buy and sell items are strictly prohibited.

*No work assembled from kits.

*No nuisance items such as water balloons, marshmallow guns, slingshots, or balloons.

*No T-shirt sales.

*No plants

*No food items.

*All work and displays must stay within designated space.

**The Guideline and Policy Committee will be checking booths to assure that all guidelines are followed.*

POLICIES:

*No Friday night sales.

*If your booth represents more than one vendor, all must be present at the show and listed on the application.

*All vendors must submit a photo of **each type** of work to be exhibited. If more than one vendor is selling items in a booth space, photos from all vendors are required. Any type of work not represented in your photos will not be allowed. Photos will not be returned

*No refunds for cancellations.

*No pets by order of county policy.

*Vendors must provide their own tent, tables, and chairs.

*Electricity is provided only on a very limited basis. Be sure to notify us on your application if you require electricity and we will do our best to accommodate you. You must provide your own heavy-duty extension cord.

*Booths are to be open 10:00 a.m. until 5:00 p.m. on Saturday and from 10:00 a.m. until 4:00 p.m. on Sunday. Booths must not be broken down before 4:00 on Sunday or you may not be invited back next year.

*Security guards are provided Friday and Saturday nights.

*CCHAC is not liable for work which is damaged or stolen.

*CCHAC reserves the right to limit any category to provide diversity of crafts throughout the Festival and to give vendors a reasonable chance for successful sales.
